

COMMERCIAL TRANSACTIONS OF GREECE : April 2025

(Provisional Data)

The total value of imports, in April 2025 amounted to 6,674.9 million euros (7,462.9 million dollars) in comparison with 7,532.5 million euros (8,056.1 million dollars) in April 2024, recording a drop, in euros, of **11.4%**. The corresponding value excluding oil products in April 2025 recorded a drop of 68.3 million euros or 1.2% and the corresponding value excluding oil products and ships in April 2025 recorded a drop of 137.6 million euros or 2.4%, in comparison with April 2024 (Table 1).

The total value of exports, in April 2025 amounted to 3,834.3 million euros (4,312.6 million dollars) in comparison with 4,482.6 million euros (4,823.1 million dollars) in April 2024, recording a drop, in euros, of **14.5%**. The corresponding value excluding oil products recorded in April 2025 a drop of 86.7 million euros or 2.7% and the corresponding value excluding oil products and ships in April 2025 recorded a drop of 87.7 million euros or 2.7%, in comparison with April 2024 (Table 1).

The deficit of the trade balance, in April 2025 amounted to 2,840.6 million euros (3,150.3 million dollars) in comparison with 3,049.9 million euros (3,233.0 million dollars) in April 2024, recording a drop, in euros, of **6.9%**. The corresponding value of deficit excluding oil products in April 2025 recorded an increase of 18.4 million euros or 0.7% and the corresponding value excluding oil products and ships in April 2025 recorded a drop of 49.9 million euros or 2.0%, in comparison with April 2024 (Table 1).

The total value of imports, for the 4-month period from January to April 2025 amounted to 27,059.2 million euros (28,857.9 million dollars) in comparison with 27,876.9 million euros (30,075.8 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **2.9%**. The corresponding value excluding oil products recorded an increase of 480.5 million euros or 2.3% and the corresponding value excluding oil products and ships recorded an increase of 435.9 million euros or 2.1%, in comparison with the period from January to April 2024 (Table 5).

The total value of exports, for the 4-month period from January to April 2025 amounted to 15,975.1 million euros (17,124.0 million dollars) in comparison with 16,827.0 million euros (18,266.2 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **5.1%**. The corresponding value excluding oil products recorded an increase of 583.9 million euros or 4.9% and the corresponding value excluding oil products and ships recorded an increase of 593.1 million euros or 5.0%, in comparison with the period from January to April 2024 (Table 5).

The deficit of the trade balance, for the 4-month period from January to April 2025 amounted to 11,084.1 million euros (11,733.9 million dollars) in comparison with 11,049.9 million euros (11,809.6 million dollars) for the corresponding period of the year 2024, recording an increase, in euros, of **0.3%**. The corresponding deficit excluding oil products recorded a drop of 103.4 million euros or 1.1% and the corresponding deficit excluding oil products and ships recorded a drop of 157.2 million euros or 1.8% (Table 5).

The monthly data of Intra-EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-EU transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by Hellenic Statistical Authority on a yearly basis.

Diagram 1. Imports, Exports, April 2023-2025, million €



April 2023–2025, million €**



April 2023-2025, million €**



January - April 2023-2025, million €**



Diagram 5. Imports, Exports, excuding oil products, January - April 2023-2025, million €





Diagram 7a. Percentage (%) distribution of E.U. imports by SITC sections, April 2025




Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, April 2025




Diagram 8a. Percentage (%) distribution of E.U. exports by SITC sections, April 2025




Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, April 2025




Diagram 9. Imports E.U. & Third countries by SITC sections, Jan. - Apr. 2025, million €




Diagram 10. Exports E.U. & Third countries by SITC sections, Jan. - Apr. 2025, million €



Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	<p>INTRASTAT is the system for collecting Intra-Union statistical data (among the EU countries). In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Independent Authority of Public Revenue.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1,000 euros are registered.
